# **IPTV Customer Formal Notice**

Cable Television Service includes video channels provided to Residential and Business customers. Also called IPTV (for internet protocol television), this service is regulated by the FCC and the state franchising authority.

Pursuant to federal Truth-In-Billing laws, within 24 hours after entering into a contract or agreement for service, the Company shall send the customer by email, online link, or other reasonably comparable means, information regarding: (a) the total monthly charge for the service selected by the consumer, including any related administrative fees, equipment fees, or other charges; (b) a good faith estimate of any tax, fee, or charge imposed by the Federal Government or a State or local government, and (c) a good faith estimate of any fee or charge that is used to recover any other assessment imposed on the provider by the Federal Government or a State or local government. The customer then has the right to cancel the contract or agreement without penalty within 24 hours after the Company provides that information to the customer.

IPTV services are provided on a month-to-month basis. Contracts are used in special circumstances

## Additional Charges for Add-On's to the above packages

#### **Premium TV**

Monthly charges for adding:

HBO is \$20.00 plus \$1.40 taxes = \$21.40 per month Cinemax is \$14.00 plus \$.98 taxes = \$14.98 per month Starz/Encore is \$12.00 plus \$.84 taxes = \$12.84 per month Showtime/TMC is \$10.99 plus \$.77 taxes = \$11.76 per month

### Set Top Boxes

All TV's require a set top box in order to receive programming. WesTel Systems supplies one "leased" boxes FREE per TV account. The additional monthly set top box fee for a DVR is \$10.00 plus \$.70 taxes = \$10.70 per month per box. The additional monthly set top box fee for a Single Stream box is \$6.50 plus \$.46 taxes = \$6.96 per month per box.

#### **NFL Redzone Season Pass**

The price for NFL Redzone season pass is an <u>annual one-time charge</u> of \$54.95 plus \$3.85 taxes = \$58.80.
